AFFIDAVIT BY THE PARENT / GUARDIAN

- 3) I have also, in particular, perused clause 7 and clause 9.1 of the Regulations and am fully aware of the penal and administrative action that is liable to be taken against my ward in case he/she is found guilty of or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.
- 4) I hereby solemnly aver and undertake that,
 - a) My ward will not indulge in any behaviour or act that may constitute ragging under clause 3 of the Regulations.
 - b) My ward will not participate in, abet, or propagate through any act of commission or omission that may be considered ragging under clause 3 of the Regulations.
- 5) I hereby affirm that, if found guilty of ragging, my ward is liable for punishment according to clause 9.1 of the Regulations, without prejudice to any other criminal action that may be taken against my ward under any penal law or any law for the time being in force.
- 6) I hereby declare that my ward has not been expelled or debarred from admission in any institution on account of being found guilty of abetting or being part of a conspiracy to promote, ragging, and further affirm that, in case the declaration is found to be untrue, the admission of my ward is liable to be cancelled.
- 7) I am aware that if my ward involves in any violations/ repeated violations, my ward will lose privileges such as scholarship and placement services.
- 8) I hereby declare that during the study period, my ward's conduct will not involve any such misconduct of the following:
 - (a) Fighting/Slander/Quarrelling Resulting in Minor/Major Injury
 - (b) Smoking / E-smoking
 - (c) Coming in Drunken State / Inducing others to consume alcohol /Bringing Liquor / Possession of liquor /Drinking inside the Campus / Possession of even an empty liquor bottle
 - (d) Not maintaining proper Dress code inside the campus premises
 - (e) Stealing/Theft
 - (f) Forgery/Multilevel Marketing / Gambling
 - (g) Drugs/Substance abuse
 - (h) Damaging the University's Property
 - (i) Any Cyber Crime / any other criminal activity / **Defaming VIT University's name in any Manner**
